#### THIRD PARTY AUDIT CERTIFICATION

Provides proof that cattle are certified for sustainable sourcing programs.

#### EASILY ACCESSIBLE AND AFFORDABLE

Industry designed and delivered training and certification for producers in all provinces in all kinds of operations.

#### TRAINING AND ON-GOING SUPPORT

#### The VBP+ Logo can be used on:

- Brochures, pamphlets, signs that describe your beef cattle operation
- VBP+ can be used/mentioned in sale videos, marketing pieces on social media to describe your operation and cattle.

#### The VBP+ Logo can NOT be used on:

- X Meat packaging or meat labels
- X To describe the beef products

**Why?** Food Labelling Requirements in Canada are very strict and fall under the jurisdiction of the Government of Canada – Canadian Food Inspection Agency. The VBP+ program covers the pre-harvest period of beef production (the management of live cattle up until the point of slaughter). The program is not involved in post-harvest beef production, so cannot make any claims to the actual beef product.

VBP+ certified producers understand the importance of sustainable beef production. These producers have implemented practices that prioritize on-farm

food safety, environmental stewardship, biosecurity and animal care which have been third-party verified at the farm level. You appreciate and respect that consumers must have confidence in the beef you raise and VBP+ certification is your proof to them that you are doing your best for them.


